- 1. ARTICLE IX, MISCELLANEOUS, Section 9.1, Term and Amendment shall be amended to read as follows:
 - 9.1 Term and Amendment. No amendment of this Declaration pursuant to this paragraph, constructed in compliance with this Declaration as the same existed on: (i) the date on which the construction of such structure commenced; or (ii) the dare on which the Owner took title to his Lot, if the construction of such structure commenced within ninety (90) days of this taking title; nor shall any amendment pursuant hereto require Declarant to relinquish any rights reserved to it under this Declaration. No amendment hereunder shall become effective prior to the time a duly executed and acknowledged copy is recorded among the Public Records of Pinellas County, Florida.
